25 21, 2007, attached hereto as Exhibit B. Defendant's answer was due on December 13, 2006.


26 3. As of this date, no answer or responsive pleading to the Complaint has been filed by

28 of Defendant to request an extension of time to respond to the Complaint.

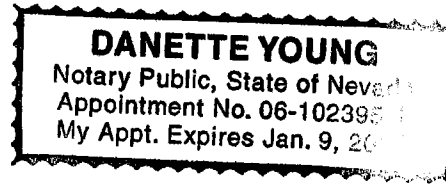
1 4. Plaintiff therefore requests for an entry of default of Defendant for failing to answer,

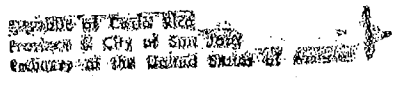
